God has given us a gracious and generous congregation. Most of us understand that we are stewards of God's possessions. As stewards, the minimum He directs us to give is ten percent (a tithe). God established his baseline in the Old Testament and has blessed His people for their obedience. People donate in different ways, and we encourage you to give in the most advantageous way possible. Check with your financial adviser, but for our older congregants, a powerful way to give is through a Qualified Charitable Distribution (QCD). At age 70 1/2 or over a direct distribution from a taxable IRA to Keystone Baptist Church can be made and does not count as taxable income. This multiplies your gift by reducing your tax liability. Since QCD gifts do not generate a charitable deduction, this is an especially effective way for non-itemizers to give. These distributions do count towards any Required Minimum Distribution (RMD) but can be made even if there is no RMD yet, as long as the account holder is at least 70 1/2. Additionally, an RMD is the minimum that must be distributed, but more can be given to qualified charities each year (i.e., up to \$108,000 in 2025).
